At least 600 patients total every 6 months are expected to be enrolled in G-COR from 25 US sites. Over the course of 3.5 years, that would yield 4,200 patients.

Dear Dr. Brown:

Thank you for inquiring about the role of participating sites in G-COR.

As you know G-COR is now starting the pilot phase, and we are actively enrolling patients at this time.

25 US sites have been invited, and 20 have already accepted and started their internal regulatory approval process including the signature of the Data User Agreement (DUA) and internal IRB approval for what we provided all sites with a copy of the G-COR protocol and a copy of our IRB approved consent form.

Subsequent to those two steps, sites will undergo a simple and straightforward protocol and database training, and users will be given access to the database for data entry.

Access for data analysis and communication will be for participating sites investigators. Participating sites, after DUA signature, IRB approval, protocol and database training will have access to the database for data entry and participation.

Participating sites that actively recruit patients will be able to propose sub studies for consideration by the scientific committee.

Members of the scientific and topics committees will participate of data analysis of the registry data and sub studies.

Sites that do not actively participate in G-COR will not have access to database or sub studies.

Hope this clarifies what the process is.
